## IAATO Membership Fee Structure 2024-25 Season

Fees within the Association consist of annual dues (applicable to all types of membership) and per passenger fees (applicable to some categories of membership). These fees (in US Dollars) are outlined below, by type of membership and activity, and are subject to change based on a vote of the Membership at the Annual Meeting.

### ***New Members' Dues & Fees:***

- **New Provisional Operator members:** \$2,500 annual dues plus the \$8.00 per passenger per day in coastal waters South of 60°S and South Georgia fee for 2024-25 season.
- **New Provisional Small Yacht\* members:** \$2,500 annual dues plus the \$4.00 per passenger per day in coastal waters South of 60°S and South Georgia fee for 2024-25 season.
- **New Associate members:** \$3,000 annual dues. (The per passenger fee does not apply.) With the provision that Associate members must pay \$1,500 for each attendee over two at the IAATO Annual Meeting.
- **New Not-for-Profit Associate members:** \$250 with the provision that they must pay \$1500 per person to attend the IAATO Annual Meeting.

### ***Dues & Fees Thereafter:***

- **Operators and Provisional Operator members** \$2,500 annual dues plus the \$8.00 per passenger per day in coastal waters South of 60°S and South Georgia fee for 2024-25 season.
- **Provisional Small Yacht\* members:** \$2,500 annual dues plus the \$4.00 per passenger per day in coastal waters South of 60°S and South Georgia fee for 2024-25 season.
- **Associate members:** \$3,000 annual dues. (The per passenger fee does not apply.) With the provision that Associate members must pay \$1,500 for each attendee over two at the IAATO Annual Meeting.
- **Not-for-Profit Associate members:** \$250 with the provision that they must pay \$1,500 per person to attend the IAATO Annual Meeting.

In addition to the fees noted above, extra fees may apply.

**Dues** are paid annually upon receipt of invoice and due by July 1<sup>st</sup> of each year, the beginning of IAATO's fiscal year.

**Per passenger fees** are broken into two payments<sup>1</sup>:

- The first payment includes a charge for 65% of the per passenger fee based on the estimated passenger load for the season ahead. This amount will be added to the invoice with your annual dues.
- The balance of the per passenger fee (from the previous operating season) is invoiced separately and due by June 30<sup>th</sup> once the passenger load for the season has been established and the fees can be adjusted appropriately.

**Attention:** Companies applying for Associate membership should take note that if their application is accepted in the months prior to the regular invoicing period (April-June for fiscal year starting July 1<sup>st</sup>), these new members also will be billed for the fiscal year that began the previous July 1<sup>st</sup>. There is no prorating of the partial year's membership.

If you are reapplying for membership and you have any outstanding invoices from a previous period of membership you will be required to pay those overdue invoices (plus any penalties assessed).

\* *Definition of Small yacht - Less than 24m at waterline (regardless of motor or sail).*
