IAATO Releases COVID-19 Recommendations as Operators Prepare for Antarctic Season

The International Association of Antarctica Tour Operators (IAATO) has released a series of COVID-related recommendations to support its members with preparations for the next Antarctic season 2021-22. The recommendations, which were released to members on June 24, have been issued as part of IAATO's mission to advocate and promote the practice of safe and environmentally responsible private-sector travel to the Antarctic.

IAATO members have diverse and unique operations. Each operator will assess the limitations on international travel to Antarctic gateways, necessary amendments to their normal health and safety protocols, and the potential impact on their own operations, team members, and guests travelling to embarkation points and gateway communities.

After 15 months of collaboration, both within and outside of the Association, IAATO has made the following recommendations to its members with the overarching goal of minimizing the risk that COVID-19 presents:

- Passengers are fully vaccinated before embarking from their gateway departure point;
- Crew members and staff are fully vaccinated before embarkation;
- In some circumstances, if vaccination is not feasible or applicable, individuals have appropriate documentation regarding recovery from COVID-19 or are quarantined following most recent medical advice and/or relevant national requirements;
- In addition to the steps listed above, operators adopt an effective testing scheme to detect the presence of COVID-19 and take the necessary steps to reduce potential spread.

In a recent poll of IAATO Operators, members demonstrated overwhelming support of these recommendations.

IAATO emphasizes that any operations in the 2021-22 season should include strict COVID-19 management protocols during each expedition to the Antarctic. These should include specific prevention and mitigation measures implemented by Antarctic gateway authorities and should be done under the guidance of operators' respective Competent Authority.

IAATO and the Antarctic gateway authorities are continuing the dialogue regarding possibilities for operations for the upcoming season. Information and updates are regularly shared with our members.
