Information Paper Submitted by the International Association of Antarctica Tour Operators (IAATO)

Introduction

IAATO is pleased to provide the statistical data compiled from vessel Post Visit Reports for the 2024-25 season and the preliminary estimates for the 2025-26 season.

We also take this opportunity to build on discussions with different Treaty Parties around growth and diversification of activities, by including a historical perspective which may aid ongoing considerations. The data presented throughout this paper is based on information provided to IAATO by its operators in Post Visit Reports (PVRs). Visitor numbers reflect only those travelling with IAATO Operator companies and do not include information from any non-IAATO operators. The visitor numbers also do not include observers, government officials, or individuals participating in research projects supported by IAATO Operators.

IAATO's membership continues to encompass most private-sector tour operators. All IAATO Operator activities in Antarctica are permitted or authorised by Competent Authorities through Environmental Impact Assessments (or equivalent), Advance Notifications and, where relevant, Waste Management Permits, submitted in advance of the season. IAATO Operators strive for safe and responsible operations in the Antarctic Treaty area and plan activities that will have no more than a minor or transitory environmental impact. 1.0 Historical Overview on Managing for Growth

1.1 IAATO Member Activities and Managing for Growth

The growth of the Antarctic tourism industry is a topic of great interest within the Antarctic and worldwide communities. Over the past three decades, IAATO has experienced several periods of growth. During each of these periods of growth and in the intervening breaks, IAATO has implemented a series of tourism management measures, many of which were subsequently adopted by the ATCPs. With advancements in technology, reporting, and communications, and building on lessons learned, IAATO has been able to accurately forecast and monitor growth, making informed decisions and implementing management measures to properly position the organization as changes occur, and respond promptly as needed.

Currently, the industry forecast indicates a slight decline in passenger numbers. As forecast in ATCM 46 (2024) IP102 *IAATO Overview of Antarctic Vessel Tourism: The 2023-24 Season, and Preliminary Estimates for 2024-25*, the 2024-25 passenger levels are approximately 5% lower than the 2023-24 season. This can primarily be attributed to one cruise only operator not operating during the 2024-25 season. The number of landed passengers remained virtually the same between the 2023-24 and 2024-25 seasons.

With a proactive approach, IAATO continues to strengthen, test, and refine its suite of 'tools' to ensure the continued successful management of activities such as those listed in ATCM 47 (2025) IP031 *IAATO Annual Report*.




Figure 1: Overview of Landed and Cruise Only Passenger Numbers 1993-24

Incremental changes to existing tools have been made during the past ten years to address the continued increase in activities. *Figure 1* gives an overview of Landed and Cruise Only Passenger Numbers 1993-24. *Table 1* provides an overview of the key growth management tools introduced by IAATO during periods of growth from 1993 to the present.

1.2 IAATO Member Nationalities

The Post Visit Report Forms submitted to IAATO indicate that more than 150 different nationalities were represented by tourists who visited the Antarctic during the 2024-25 season. *Table 2* offers a summary of the 2024-25 season nationalities by percentage.




Figure 2: Top 10 Passenger nationalities (vessel and deep field) travelling with IAATO operators between 2019-24

Reflecting on the last five years of active expeditions (2019-24), the Post Visit Reports submitted to IAATO indicate the top 10 nationalities who visited Antarctica have remained relatively consistent over the last 10 seasons, although proportionately and before the pandemic, China had seen the greatest increase in travellers to Antarctica. An overview of the past five years is presented in *Figure 2*.

2.0 IAATO Vessel Operations Overview

This section focuses on IAATO Vessel Operations and includes yacht activities.

For Deep Field and Air Operator information, please refer to ATCM 47 (2025) IP033 *IAATO* Deep Field and Air Overview of Antarctic Tourism: 2024-25 Season and Preliminary Estimates for 2025-26 Season.

2.1 IAATO Vessel Activities

For the last 34 years, shipborne tourism on the Peninsula has been the dominant vector of travel. Most tourism voyages (98%) operate in the Antarctic Peninsula region during the seven-month austral summer season (from October to April), and depart from Ushuaia, Argentina or, to a lesser extent, from other ports north of the Antarctic Treaty Area.

During the 2024-25 season, all commercial SOLAS passenger ship operators conducting tourism activities in the Antarctic Treaty Area were members of IAATO.

Table 3 provides a summary of the last decade 2014-24 of both IAATO SOLAS and non-SOLAS vessel tourism, including Yachts and Cruise Only.

In accordance with IAATO Bylaws Article X – Section B, all operators and provisional operators are to comply with operational conditions pursuant to the Antarctic Treaty System, including the Antarctic Treaty and the Protocol on Environmental Protection to the Antarctic Treaty, along with IMO Conventions and similar international and national laws and agreements.

2.2 Scope of IAATO Vessel Activities

Commercial tourist activities included the operation of small inflatable boats (such as Zodiac, R.I.Bs. and Naiad), shore landings, and, to a lesser extent, activities such as, but not limited to, kayaking, climbing, and short overnight stays.


Over the years, descriptions and types of activities have been expanded in the Post Visit Reports to facilitate greater accuracy in reporting and planning. For instance, RPAS Flights, although banned recreationally in coastal waters by IAATO, have been expanded to differentiate between commercial, scientific, and operational/navigation flights. Likewise, what was once described as swimming has now been expanded to swimming – distance and polar plunge.

Figure 3 illustrates activities offered by IAATO vessels, including yachts, during the 2024-25 season. Small boat cruising and landings remain the most popular activities (approx. 49% of all activities) for vessels, while scenic ship cruising also remains a key activity (43%). A range of other off vessel activities (e.g., kayaking and short overnight stays) contribute to a smaller portion (approx. 8%) of off-ship activities. It is anticipated that ship cruising, small boat cruising and small boat landings will continue to be the dominant activities and "other" activities will remain small-scale in comparison.




Figure 4: Top 10 "other" off vessel activities between 2019-24




Figure 5: Differentiation of Helicopter Activities 2019-24




Figure 6: Differentiation of Skiing Activities 2019-24

As a percentage of the total activities, *Figure 4* illustrates the top 10 "other" off vessel activities between 2019 and 2024. *Figure 5* demonstrates how helicopter activities have been differentiated and expanded for accuracy of reporting between 2019 and 2024. *Figure 6* demonstrates how skiing activities have been differentiated and expanded for accuracy of reporting between 2019 and 2024.

Figure 3: Commercial Operated Activities Conducted from Expedition Vessels and Yachts for 2024-25

4.0 Preliminary Estimate of Planned Vessel Activities for the 2025-26 Season

Preliminary estimates for Vessels, found in Appendix 2, for the 2025-26 season are as of May 9, 2025. These estimates represent the anticipated operating scenario for the 2025-26 season.

5.0 Tourism Statistics

IAATO has been collating data from its members' visits to Antarctica for three decades. During that time, changes have been made in the data collected, which encompass more detailed activity categories as well as updates to site names. Until recent years, the collating was done manually. Increased capabilities in technology have allowed large data sets to be analysed more effectively and quickly than previously possible. This has brought to IAATO's attention certain anomalies in the historical data (i.e. terrestrial landings at marine-only sites). Therefore, IAATO strongly recommends utilising the most recent information available from IAATO when performing analysis.
